“Early this fall, we will have fly tying classes as usual at St Augustine Church in SM. They are on the 4th Saturday of the month: Sept 22, Oct 27, and Nov 24, just after Thanksgiving. As always people may tie whatever they personally need or want. But in September, I will be tying Rampy’s streamers (for club trip to the Williamson), in October, small beatis or blue wing olives (for club trip to Hot Creek), and for November, foam bodied terrestrials.

Hot Creek: November 2-5, 2018

Don't forget to make your 2018 Hot Creek reservation. Although the trip isn't until November, full payment (\$415 per person) is due no later than October 1, 2018. Member Corner

Here is an up to date report on a few of the fishing venues I've been fishing recently.(July 14, 2018)

Big Wood River - I made my inaugural visit to the Big Wood yesterday afternoon for a couple of hours. It was hot - 89 degrees - but wet wading made it comfortable. The river is in great shape, just a bit high but totally clear and 95 % fishable. I lost count of the number of strikes, but I would estimate 15-20 from the first long run, all wild rainbows in the 7-12" range, all on dries. I caught several more from an upstream run and called it a day after I landed a 15er. The river is fishing very well (far better than this time last year with the big winter runoff) with mostly smaller fish and a few larger specimens mixed in. No need for nymphs right now.

Silver Creek - the big news here is that a local angler with a guide landed a 28 inch brown last week which is one of the largest dry fly caught fish on the Creek in the last several years. The brownie took a size 18 sparkle dun on 6x tippet around noon on a bright sunny day. It took him a full half hour to land the beast and they reportedly chased the fish 1/4 mile downstream. Released "unharmd" although I'm not sure I believe the unharmd part.


Bitterroot - we had some good fishing, at times excellent, around the Bitterroot Valley where we visited for a few days earlier this week, but not on the main river. The main stem and West Fork are both fishing well for floating and we met several anglers who reported 50 fish days with a guide. But all the rivers and even the tributaries are still running high and that made wade fishing on the main stem very limited and difficult if not impossible to reach productive holes on foot. And there was heavy, heavy boat traffic. But there are so many places to fish around the valley that we had no trouble finding solitude and productive water. Also very warm up in Montana.

Still making plans for the coming week. More to follow.

3 Things To Know About the ESA Rollbacks and 2 Things You Can Do About It.



Endangered and threatened species need our help.

Recently the current administration unveiled a proposal that would **strip the Endangered Species Act of key provisions**. The proposal would weaken the law enacted 45 years ago to keep plant and animal species that are in decline from going extinct. The changes would end the practice of extending similar protections to species regardless of whether they are listed as endangered or threatened

1. The rollbacks would allow officials to devalue science and consider economic impacts when deciding how wildlife should be protected.

The proposal would remove the phrase "without reference to possible economic or other impacts of such determination. Referencing costs and other impacts "could undermine best available science" if it causes federal officials to think twice about protecting a species. Rollbacks also remove scientific and wildlife agency consultations before approving permits for ventures such as oil and gas drilling and logging.

2. A mass killing of species in the event of an anthropogenic catastrophic event would no longer be punished or held accountable.

Catastrophic events, such as the Deepwater Horizon oil spill that destroyed or injured up to a million birds, would no longer be punished or held accountable under weakened regulations.

3. Currently listed species will remain, but rollbacks will make it easier for officials to delist species and harder to list new species faced with the consequences of a changing climate.

Climate change is the single, overarching factor affecting California's salmon, steelhead and trout ranking as a critical or high threat to 84% of the species (SOS II). The ESA defines a threatened species as one "that is likely to become an endangered species within the foreseeable future throughout all or a significant portion of its range." The new proposal would allow agencies to define "foreseeable future" on a case-by-case basis. The lack of a clear definition and ambiguous language does not leave room for potential impacts induced by climate change.

TAKE ACTION - 2 things you can do to STOP this.

1. Submit A Public Comment

Submit your comments about the ESA proposal to the government before the comment period ends on September 24, 2018. Use the sample below or write your own.

As a Californian who values the vitality of native fish species and healthy waters, I do NOT support the revisions of regulations for prohibitions to threatened wildlife. There are 11 native salmonids that are listed as federally threatened. If present trends continue, 45% of California's native salmon, steelhead, and trout are likely to be extinct in 50 years and 74% in 100 years. We cannot let things get worse. I urge you to keep our Endangered Species Act strong and protect our currently endangered and threatened species - as originally intended - and protect those who may face the consequences of climate change in the future.

2. Send a Letter to Washington

Let your Senators and Representative know you oppose this plan.

Endangered and threatened species need our help.
